I am requesting authorization to hire a full time dispatcher to fill the vacancy created by the resignation of Dispatcher Tricia Popham.

Dispatcher Popham's resignation creates a third vacancy. I have started the process of hiring the first two that were authorized, and am requesting authorization to fill the third position during this process.

I reviewed the criteria that was established in the Board of Commissioners motions 14-M-03 and 14-M-018, and have attached the results of that review process. I respectfully request these positions be maintained as they are.

Once all the above positions are filled, we will once again be fully manned which will greatly reduce our overtime.

Potential Cost Reduction Review Criteria Before Filling Vacancies

1) Changing full-time positions to part-time -

Dispatch operates on a 24/7 basis and requires a minimum of two people working at all times. Changing any of these positions to part-time would actually increase our costs. We would have to hire additional part-time in order to maintain coverage. Part-time employees would also increase our training costs due the State mandate that in order to receive State surcharge funding dispatchers have to have 24 hours of training every two years. Additionally, part-time personnel can not maintain the skill level needed in order to provide quality emergency services to the community.

2) <u>Reorganization and re-assignment of responsibility within the department</u>. – Dispatch only has two supervisors to oversee 10 dispatchers when fully staffed. Re-assigning them to full time or part – time dispatch duties would only decrease our service level as we would not be able to perform evaluations, meet the criteria set by FOIA, maintain our CAD system with updates, oversee LEIN policies, etc.

3) Use of staff resources between different departments -

Dispatch only has one department and there are no other departments with in the county that perform the same service.

4) Fees and other revenue methods to defray costs -

Dispatch receives funding through surcharge, State surcharge and training fund, and from tower rent.

5) Joint service deliver with other entities including county, city or townships -

There are no means for joint services at this time as we dispatch emergency personnel for the entire county.

6) <u>Reduce personnel using online services to reduce demands on office staff</u> – There currently are no online services to reduce any costs.

7) Contracting for service with other public and private sector entities -

Contracting any services that are performed by dispatch would again reduce the service level that the community expects from Central Dispatch.

8) <u>Reclassification to lower pay grade</u> -

The only reclassification possible is to demote a supervisor to dispatcher. If this were to occur, we would see the same results as in item #2 above.

Dear Enforcing Agency:

The State Construction Code Commission has directed that a letter be sent to all local units of government as a reminder that to properly administer the Stille-DeRossett-Hale Single State Construction Code Act, 1972 PA 230, and apply the state construction codes, the jurisdiction must have access to the standards referenced in the code books in addition to the various code books themselves. This applies to jurisdictions already enforcing the code(s) and jurisdictions who may apply in the future to enforce the code(s) under Section 8b(6) of 1972 PA 230. The commission is encouraging all existing enforcing agencies to start a library of or provide access to the referenced standards.

The first national model codes published in the 1950's were prescriptive in nature and referenced only a few standards. As the code development process advanced it became clear that it was more efficient to rely on references to these standards as opposed to incorporating them in the codes. Standards writing organizations do a very good job of updating standards as the science changes. Therefore, the code development process now focuses on which standard is to be applied and to what, rather than including all the language from a standard. Today's codes alone do not provide the details necessary for plan review and construction.

If a plan reviewer does not have access to the standards, he/she cannot verify that the structural, fire protection, electrical, mechanical, and plumbing systems are in compliance with the code as the verification criteria is not in the code, but in the standard. Therefore, it is critical that an enforcing agency has access to these standards to assure the public health, safety, and welfare.

As a result, local units of government applying to enforce the codes under 1972 PA 230 must demonstrate that they already possess the referenced standards or have immediate access to the standards for all the disciplines for which they seek authority. This is not a new requirement, but previously the Bureau of Construction Codes would accept a statement from a local jurisdiction that the codes and standards were available. What was found, however, is that there was often confusion and instead of jurisdictions having the referenced standards available only the code books were available.

"Access" is being defined to mean that the plan reviewers and inspectors in an enforcing agency have practical use of the standards to facilitate proper code enforcement. This access can be provided in different ways. For example, an enforcing agency may purchase the standards and maintain its own library, an enforcing agency may have privileges to use a university or professional society library, or several governmental subdivisions may form a cooperative to fund and maintain a library.

The Construction Code Commission and the bureau recognize that creating a full library of standards would be very costly—in excess of \$100,000 for all the standards. In response to cost concerns from local units of government, the bureau has created a list of *essential* referenced standards that pares the full list down to those standards most likely to be needed on a regular basis to enforce the codes. A complete library of *essential* standards would cost under \$30,000, a significant reduction from the cost of a full library. A list of the essential standards is available on the bureau's website at <u>www.michigan.gov/bcc</u> under "What's New" and is provided in both summary and individual code format.
