Dear Mike:

You asked below whether the proposed ballot language regarding the MSU extension ballot language is consistent with that which in my opinion is necessary to allow funds from the general fund to be used in 2016 for MSU Extension and repaid from millage funds in later years. The reason for this is so that the expenses which will ultimately be paid from millage funds are incurred in a year covered by the levy of the millage.

I have reviewed the language below and I do find it appropriate in the above respect. The language also meets the applicable requirements under MCL 211.24f. I also note that MCL 285.51 specifically authorizes a county to raise funds by taxation for agricultural extension purposes.

The current draft of the MSU-e ballot language reads as follows:

### Tuscola County Michigan State University Extension Millage Proposal

For the purpose of sustaining 4-H youth development, agriculture and agribusiness, health and nutrition and other community education programs through Michigan State University Extension services within Tuscola County, shall the County increase the limitation in the total amount of ad valorem taxes which may be imposed for all purposes upon real and personal property in the County, as provided in the Michigan Constitution of 1963, as amended, which would result in a new levy of 0.1 mills (\$0.10 per \$1,000) of taxable valuation, for a period of six (6) years, in the years 2016 to 2021, both inclusive? This levy is estimated to raise \$173,094 in the first year. You mentioned the importance of including 2016 in your opinion concerning repaying a loan from the general fund that would be used in 2016 to sustain MSU programs in 2016. My understanding is that the ballot language applies to the year the tax is levied. In other words, funds would be levied in 2016 and collected in 2017......levied in 2021 and collected in 2022.....

Your statement in your opinion regarding the loan stated in part: "In doing so, it will be important that the years covered by the millage include 2016", as well as that the purposes set forth within the ballot language include the expenditures to be reimbursed to the general fund.

Dear Michael,

I am writing to update you on activities on Capitol Hill. As you know, we face the prospect of Washington forcing every state to allow longer double-trailer trucks that are 85 feet in length (sometimes called "Twin 33s" or "double 33s"), as we have seen in both the House and Senate transportation appropriations bills. And, we are once again seeing a push to increase truck weight above the current 80,000-pound limit, ranging from 91,000 pounds to 97,000 pounds.

First, the Senate passed its long-awaited transportation reauthorization bill, or the DRIVE Act. This bill did not include language for longer double-trailer trucks, 91,000 pound or 97,000 pound trucks. In fact, Sens. Diane Feinstein (D-Calif.) and Roger Wicker (R-Miss.) offered a bipartisan amendment that would require the U.S. Department of Transportation (USDOT) to determine that double 33s were safe through a study process before allowing the configuration nationwide. While the Feinstein-Wicker amendment did not ultimately receive a vote, their efforts sent a strong bipartisan message in opposition to double 33s.

The focus now turns to the House Transportation and Infrastructure Committee, where leadership has stated their intention to have a full highway bill markup when Congress returns from its recess in September. The debate over double 33s, 91,000-pound trucks and 97,000-pound trucks will then be front and center.

While all of this continues to play out over the next few months, it is important to remember, and remind Members of Congress, that the USDOT released its technical reports in June and recommended against any increases in truck size and weight. This is the study Congress directed USDOT to conduct. Our lawmakers need to listen to the experts. Please call your Members of Congress and remind them of this conclusion by USDOT.

Thank you for all your efforts in keeping heavier and longer trucks off of our roads. Please let me know if CABT can be of any assistance.
