HUMAN DEVELOPMENT COMMISSION

Proposal to Continue as a Tuscola County Outside Contractor for Foreclosure Prevention

Purpose of the Request

The Human Development Commission (HDC) offers free, confidential foreclosure prevention counseling for county residents who are facing (or threatened with) the loss of their single, largest asset – the family home – due to mortgage and/or property tax delinquency.

HDC would like to continue as an outside contractor for Tuscola County to help homeowners, in particular land contract holders, avoid foreclosure due to delinquent property taxes. In fiscal year 2016 (October 2015 through September 30, 2016), HDC's foreclosure staff counseled 13 county residents that had delinquent property taxes. Two of the 13 (15.3%) were land contract holders.

How Funds Would Be Expended

HDC has continued interest in accessing funds from the county's *Delinquent Tax Property Soles Proceeds* account as payment for foreclosure prevention counseling. The county would be the "payer of last resort" after all other funding sources like the Michigan State Housing Development Authority and NeighborWorks are billed. It is HDC's experience that land contract holders with delinquent property taxes are the most challenging customers to obtain counseling funds for, as many funders do not consider these customers to be homeowners.

Foreclosure prevention counseling would include an assessment of the homeowner's financial capabilities and a review of options (e.g., Step Forward, The Michigan Hardest Hit Funds[®] Program; Poverty Exemption Letter to Township; etc.) to avoid foreclosure due to delinquent property taxes. Counseling services would also include referrals to other resource agencies that may help the homeowner with such needs as employment, health care, and nutrition.

Amount of Funds Requested

HDC requests financial consideration of \$2,000 - \$3,000 for calendar year 2017. This funding request would serve eight-to-twelve households, using "payer of last resort" funds.

Other Information

HDC is a HUD-approved Housing Counseling Agency that provides education and counseling services for homebuyers and homeowners in the "thumb" area. In addition, the agency has adopted the National Industry Standards for Homeownership Education and Counseling, which is a set of guidelines for quality homeownership and counseling services that includes a Foreclosure Intervention Specialty.
