A Drainage Board Meeting to Add County to a Drainage District will be convened through remote electronic access as provided in this Notice. Proceedings at this hearing are being conducted pursuant to the provisions of the Michigan Open Meetings Act and Executive Order 2020-15 (COVID-19) issued by Governor Gretchen Whitmer on March 18, 2020. The subject matter of this proceeding is of urgent concern for the public health, convenience or welfare of Tuscola County and Sanilac County and is therefore deemed as a necessary proceeding to be held electronically by the Krapf Drain Drainage Board.

This remote electronic meeting is an opportunity to review the addition of Sanilac County to the Krapf Drain Drainage District. The Drainage Districts currently consist of lands located solely in Tuscola County.

At the meeting, the Drainage Board, which for purposes of this meeting shall include the Tuscola County Drain Commissioner, the Sanilac County Drain Commissioner, and a deputy for the Director of the Department of Agriculture and Rural Development, shall consider any evidence offered and determine whether the addition of Sanilac County to the Krapf Drain Drainage District is just and equitable.

All persons owning lands in the Drainage Districts or proposed revised Drainage Districts liable to assessment for benefits and any municipality affected may participate electronically for or against the addition of the County.

The Drainage Board Meeting is being convened electronically to comply with the Governor of Michigan's Executive Orders and federal and state agency recommendations to cease from any public assemblies, self-quarantine, and help prohibit the spread of COVID-19. The Krapf Drain Drainage Board nonetheless recognizes its continued responsibility to facilitate responsible decision-making of the Drainage Board and has established procedures to conduct this meeting in a manner that effectuates as fully as possible the purposes of the Open Meetings Act.

Individuals are invited and encouraged to actively participate through electronic means, including providing public comment during the designated portion of the proceedings. For those seeking to participate electronically through online audio-conferencing, participants can access the electronic meeting through the following link: <https://zoom.us/j/223646835>. Participants may use any device that supports the Zoom app, which includes many computers, laptops, smartphones, and tablets. For those that choose to access through the Zoom app, you will be prompted to download the Zoom app to participate. Additionally, users on a computer or laptop will be given the option to join the meeting through a web browser without downloading the Zoom app. It is recommended that participants seeking to download the Zoom app do so well in advance to a scheduled meeting's start time so that technical advice can be obtained prior to the scheduled meeting, if necessary. 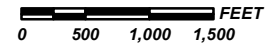
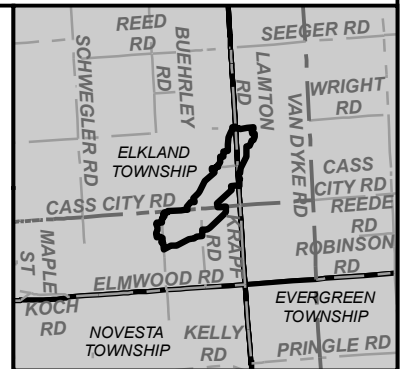
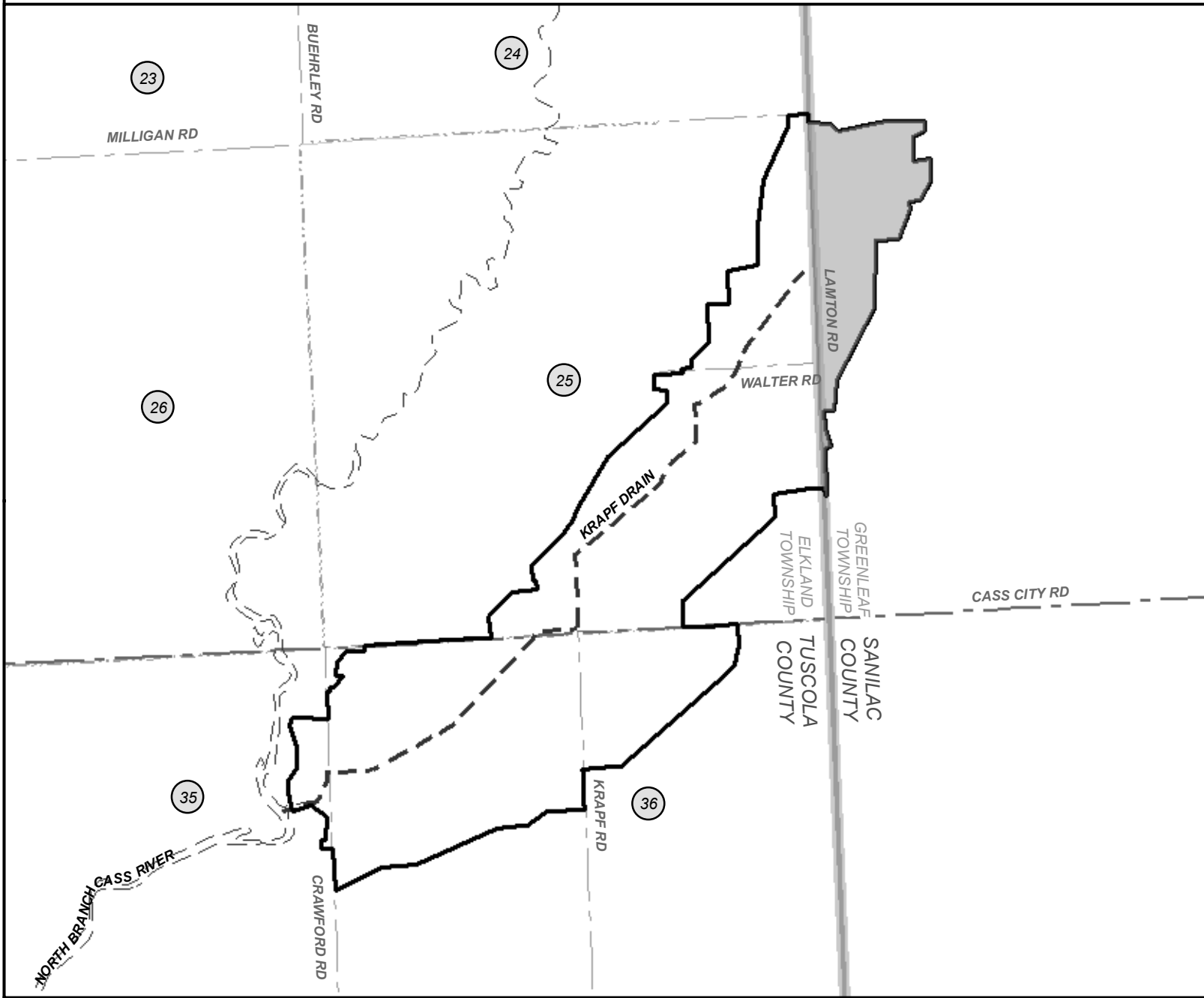
