TUSCOLA COUNTY CERTIFICATE OF ELECTIONS

The statements of votes polled in the City of Vassar, the townships of Vassar, Tuscola and the non-Caro School portion of Juniata voting precincts of the County of Tuscola at the Regular Election held on February 22, 2005 and filed with the County Clerk and this Board, having duly examined and considered the statements, the whole number of votes given for and against the proposition reading as follows:

I. Bullard Sanford Memorial Library Millage Proposal

Shall the Bullard Sanford Memorial Library, County of Tuscola, Michigan, be authorized to levy a new additional millage in an amount not to exceed .25 mill (\$.25 on each \$1,000 dollars of taxable value) against all taxable real and tangible personal property within the Bullard Sanford Memorial Library District for a period of four (4) years, 2005 to 2008, inclusive, for the purpose of providing funds for all District Library purposes authorized by law; the estimate of the revenue the District Library will collect if the millage is approved and levied by the Library in the 2005 calendar year is approximately \$49,600? A portion of the revenue collected may be subject to capture by the Vassar Downtown Development Authority and the Economic Development Corporation of the City of Vassar, and a portion may also be disbursed to the Fairgrove District Library pursuant to a library services contract.
