A. Citizen Planner:

B. Historical Resources Project:

The project is up and running on the County website, under information, and some e-mails from active citizens with information that helped fill in the project further came in. They included the Heritage Hall Building at the fairgrounds, surveys of the County from the 1820s and 1830s, and the inception of the County from circa 1850.

C. Local Visitations Communications:

Ray will visit Wells Township in April. Lou has Almer and Ellington Townships planned for April 18. Cindy is working on her visitations this month, as well.

D. G.I.S. Report:

Ray has volunteered his time and expertise to help the County get started on a G.I.S. by talking to Mike and Walt in the Equalization Department. After getting the project off the ground and persistently offering to volunteer his time after hours to train whoever would be working on the project, progress seems to be at a stand still. Ray's work on this matter was already above and beyond the duties of his position on this Planning Commission and beyond

the inception and assistance to the project, the responsibility now falls to the County and its employees if this project is to come to fruition. G.I.S. is standard for almost every other county and Tuscola is one of the few that still doesn't have it. G.I.S. is good for development because it easily communications the necessary information to investors and developers who are looking for places for new projects. Without it the County is certainly losing out on vital dollars that would grow our local economy.
