**RE: Water line**

Tuscola County will be accepting bids on the installation of a new water line at Vanderbilt Park. The following specifications shall be considered in your bid:

Location: 4446 Bath RD Fairgrove, MI 48733

1. Contractor shall provide a 1 (ONE) inch Copper line from curb stop to inside storage building.
2. Length of run is approximately 240 feet.
3. Copper shall be K-type for underground installation. Line is to be installed at a minimum of 4 foot deep (48 inches) either by boring or trenching.
4. Contractor shall provide necessary plumbing inside the building for the meter and for an outdoor hose bib.
5. Contractor will have to saw cut the existing concrete floor in the storage building to allow new line access. Once line is installed and protected, floor shall be patched to original finish.
6. The storage building is an unheated space and contractor must provide enough clearance for easy installation and removal of the meter for the seasons.
7. Contractor shall install 1(one) hose bib on the northeast corner of the building, plumbed from meter, to allow access to campers for fill water tanks.
8. Contractor shall provide the necessary protection to the public during construction process, including but not limited to barrier tape or fence
9. Contractor shall repair and damage to lawn, including but not limited to grading and reseeding.

Contractor shall provide any needed permits to complete this project and must follow all local, State, and Federal construction codes.

Call Miss DIG (811) prior to any ground disturbance.

Contractor shall provide copies of liability and worker's comp insurance, before work can begin.

State Recreation Passport grant funding is being used for this project.

Only **Sealed** proposals labeled "Park Water Line" shall be submitted to the Tuscola County Controllars office 125 W. Lincoln st, Caro, and MI 48723 no later than 4:00pm July 28, 2017.

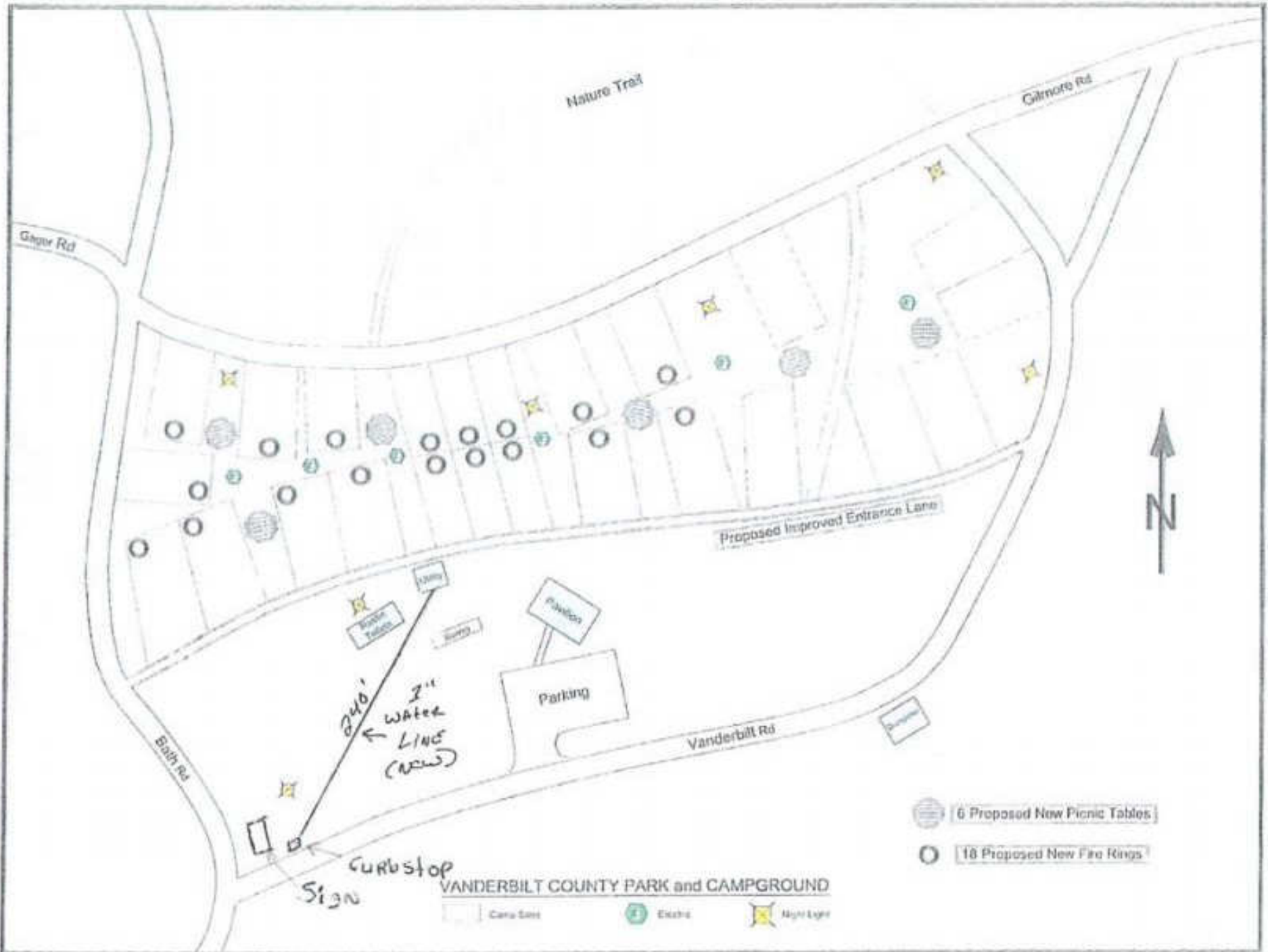
