Pursuant to Section 28.434a of the Michigan Compiled Laws this is public notice or intent to dispose of the following (see attached list) of forfeited or unclaimed firearms. After 30 days the posting will be removed and all/any of the listed firearms will be sold.

The Tuscola County Sheriff's Office has 17 long guns and 13 handguns that are to be sold by bid to a licensed FFL dealer. They are all forfeited or unclaimed firearms. Conditions range from poor to excellent, with some needing repair or parts. A list of the items available for sale is attached and they can be inspected at our office by appointment with Undersheriff Skrent or I.

Bids can be made for the entire lot or specific firearms and they will be released to the highest bidder in the best financial interests of the Sheriff's Office. We have established a reasonable minimum price that must be met or any individual firearm will not be sold and held for future liquidation.

Please contact me with any questions or to set up an inspection date and time. A decision on the sale and delivery will be made after they have been posted on our website for 30 days as required by statute. This will be approximately September 27, 2016.
