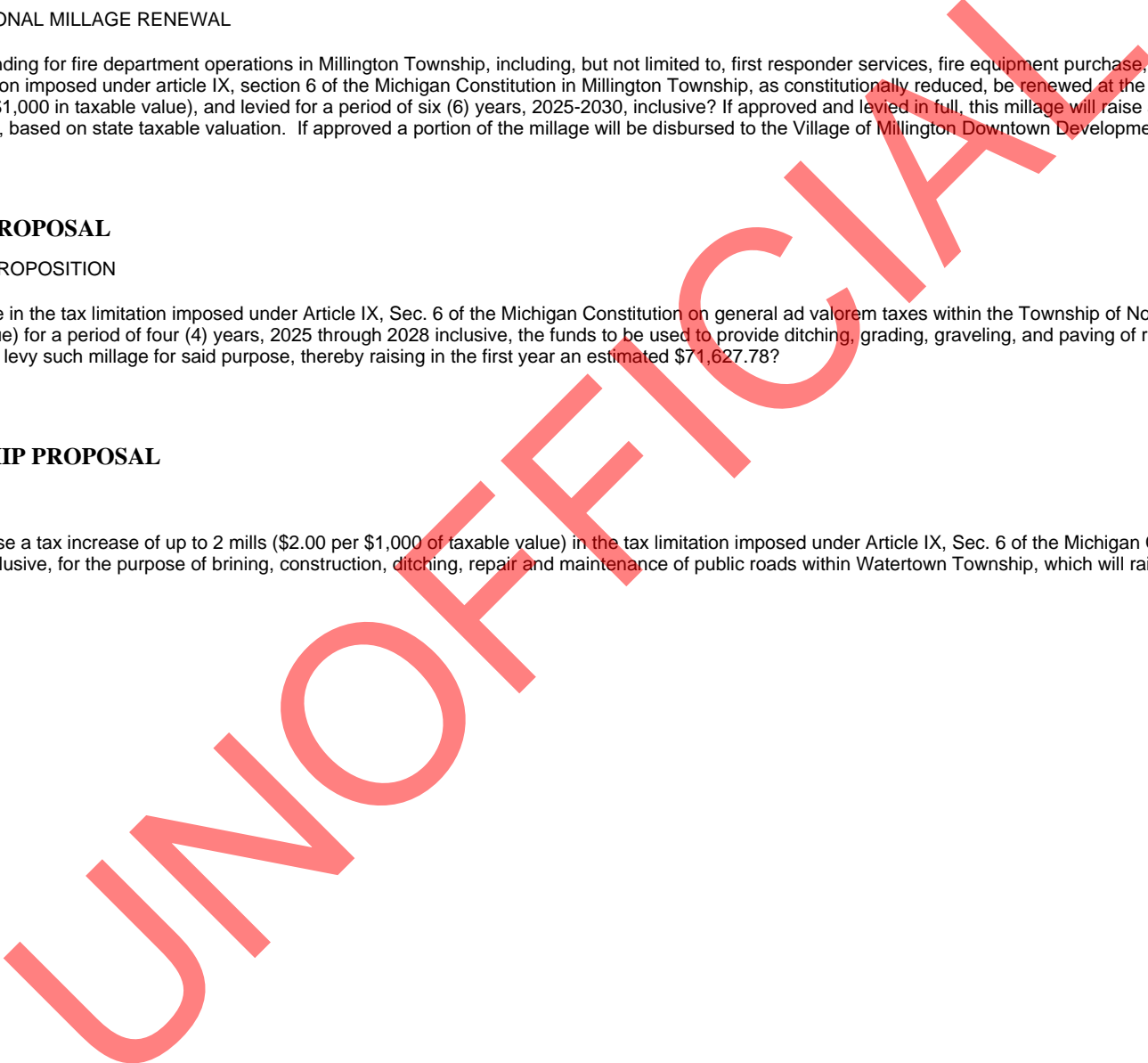

The maximum number of years the bonds may be outstanding, exclusive of any refunding, is sixteen (16) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 3.72 mills (\$3.72 on each \$1,000 of taxable valuation).

(Pursuant to State law, expenditure of bond proceeds must be audited and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)

FRANKENMUTH SCHOOL DISTRICT PROPOSAL

I. Frankenmuth School District Operating Millage Proposal

This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its full revenue per pupil foundation allowance and restores millage lost as a result of the reduction required by the Michigan Constitution of 1963.

II. Frankenmuth School District Sinking Fund Millage Renewal Proposal

This proposal will allow the school district to continue to levy the building and site sinking fund millage that expires with the 2024 tax levy.

Shall the currently authorized millage rate of 1.9964 mills (\$1.9964 on each \$1,000 of taxable valuation) which may be assessed against all property in Frankenmuth School District, Saginaw and Tuscola Counties, Michigan, be renewed for a period of 6 years, 2025 to 2030, inclusive, to continue to provide for a sinking fund for the purchase of real estate for sites for, and the construction or repair of, school buildings, and all other purposes authorized by law; the estimate of the revenue the school district will collect if the millage is approved and levied in 2025 is approximately \$1,212,977 (this is a renewal of millage that will expire with the 2024 tax levy)?

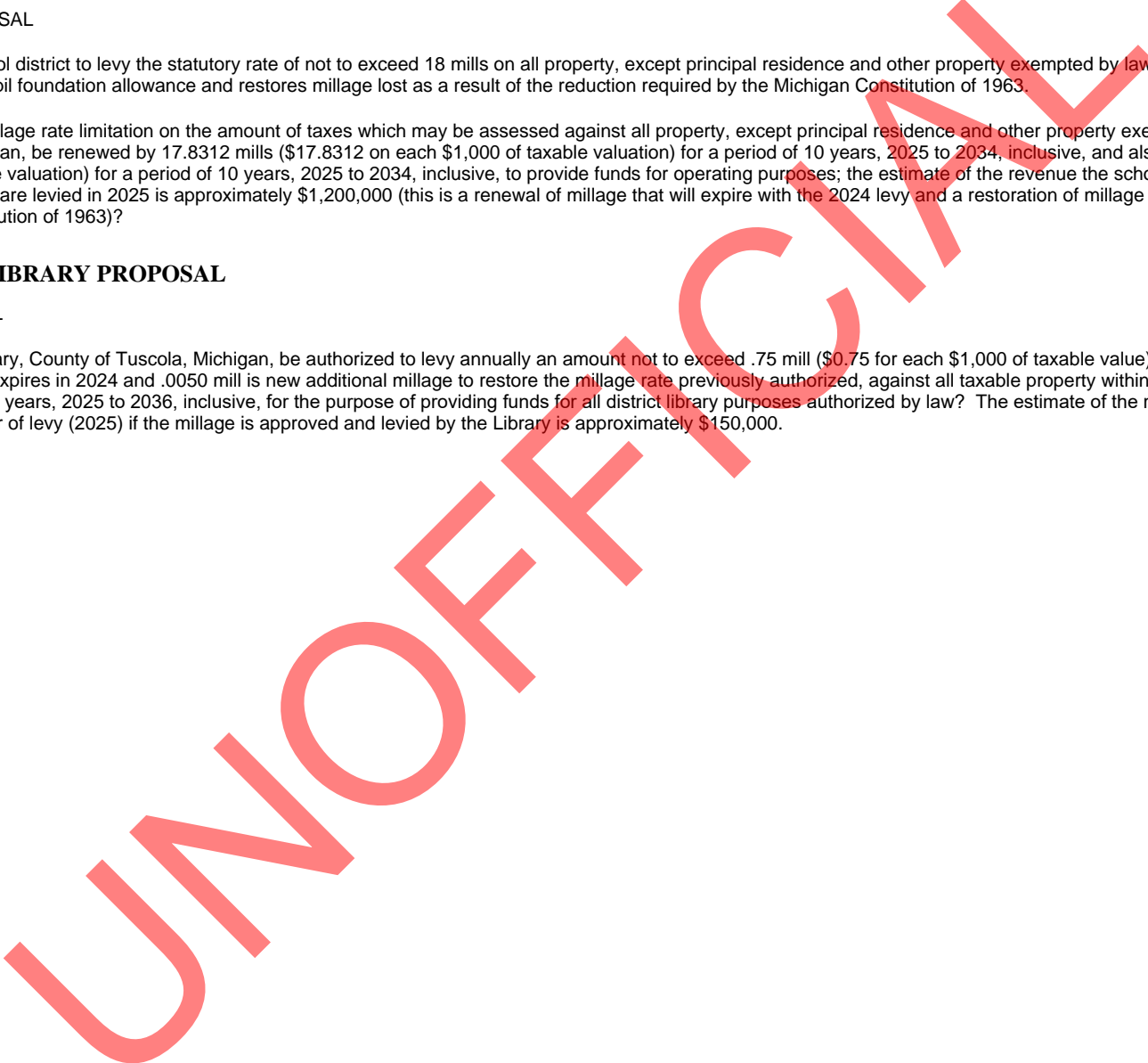

Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Vassar Public Schools, Tuscola County, Michigan, be renewed by 17.8312 mills (\$17.8312 on each \$1,000 of taxable valuation) for a period of 10 years, 2025 to 2034, inclusive, and also be increased by 0.5 mill (\$0.50 on each \$1,000 of taxable valuation) for a period of 10 years, 2025 to 2034, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2025 is approximately \$1,200,000 (this is a renewal of millage that will expire with the 2024 levy and a restoration of millage lost as a result of the reduction required by the Michigan Constitution of 1963)?

RAWSON MEMORIAL LIBRARY PROPOSAL

LIBRARY MILLAGE PROPOSAL

Shall the Rawson Memorial Library, County of Tuscola, Michigan, be authorized to levy annually an amount not to exceed .75 mill (\$.75 for each \$1,000 of taxable value), of which .7450 mill is a renewal of the millage rate that expires in 2024 and .0050 mill is new additional millage to restore the millage rate previously authorized, against all taxable property within the Rawson Memorial Library district for a period of twelve (12) years, 2025 to 2036, inclusive, for the purpose of providing funds for all district library purposes authorized by law? The estimate of the revenue the Rawson Memorial Library will collect in the first year of levy (2025) if the millage is approved and levied by the Library is approximately \$150,000.
