Tuscola County will be accepting bids on the Demolition of a Pump House. Location is the North West Corner of Chambers RD and Washburn RD Caro MI 48723. The following specifications shall be considered in your bid:

- Contractor shall be responsible for any needed permits. Will need Demolition and possible soil erosion.
- Contractor shall field verify measurements.
- Contractor shall remove above ground structure, including first floor.
- Contractor shall remove all equipment, fixtures, pumps, and stairway. Everything is to be removed other than the supply pipe from river and supply pipe to old prison.
- Supply pipes are to be capped off. A drain pipe may exist that would also need to be capped.
- Concrete shall be poured to a depth to encapsulate the supply pipes.
- Contractor shall install pea stone on top of concrete to a height of 12 inches below grade.
- Contractor shall install sand on top of pea stone to an 8 inch depth compacted.
- Contractor shall then install a 4 inch concrete pad with wire. Pad will cover entire foundation.
- Concrete pad shall be back filled around the pad to provide a smooth transition to grade.
- Contractor is responsible for clean up of job site.
- All work is to be completed by qualified personnel
- Contractor shall be insured and provide copy of liability insurance and workmen's comp.

The debris from the project shall be disposed of following Local, State and Federal rules.

Contractors must call for an appointment to view the project.

Proposals shall be submitted to County Controllers office, to the attention of Buildings and Grounds at 125 W. Lincoln St. Caro, Michigan 48723, no later than 4:00 p.m. February 3, 2023.
